**Rates and Rules Governing the Transportation Persons**

To transport, as a common carrier, by motor vehicle, persons in a paratransit service, from points in the counties of Montgomery and Philadelphia, to points in Pennsylvania, and return; provided that:

- (i) All service originating in Montgomery County shall originate from Whitemarsh Township or from Mercy Suburban Hospital or Einstein Montgomery Medical Center, each located in East Norriton Township and:
- (ii) All service shall be rendered in vehicles staffed with a Pennsylvania-certified Emergency Medical Technician or Pennsylvania-certified paramedic who possesses current Cardiopulmonary Resuscitation and Emergency Vehicle Operating Course certifications.

## **RULES AND REGULATIONS**

### **Advance Reservations**

Advance reservations must be made at least one hour prior to the service being rendered.

### **Rate Computation**

Rate shall be computed from the odometer reading of the vehicle or fraction thereof. The rates begin from the time of departure from the pick-up location of the customer and end at the arrival at the final destination.

### **Holiday Rates**

Service provided during the following holidays will be assessed at 150% of the published charge: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. New Year's Eve and Christmas Eve will be charged at the standard rate.

### **Additional Expenses**

Any and all charges for parking entrance fees, highway tolls, bridge and tunnel tolls, or other required expenses will be the responsibility of the customer and added to the carrier's charges.

### **Promotional Fares**

Upon presentation of advertising coupon or special promotional offer, carrier will offer rates at a specified discount from the published tariff rates on dates authorized by the coupon or special offer. The advertised coupon or special offer will be filed with the PA PUC prior to publication or broadcast. Coupons will be published and promotional offers will be presented in one or all of the following media: Local newspaper, flyers, radio, television, and internet.

### **Subscription Rates**

Annual subscription drive members will receive a 25% discount on their total fare exclusive of additional expenses, as listed above.

### **Overnight Trips**

Expenses for driver's lodging and meals while on trips out of town, which are in excess of 10 hours, will be added to the total cost of the trip.

## **SCHEDULE OF RATES**

Per Person

**Base rate per person:**

\$35.00	one way
\$70.00	round trip

**Group base rate (up to 8 passengers (2 wheelchairs, 6 seated)):**

\$150	one way
\$300	round trip

**Mileage rate:** A per mile charge is incurred, which includes mileage from the person's pick up location to their destination.

Free	0-4 miles
\$3.00 per mile, or fraction thereof after initial 4 miles	

**Extra Attendant:**

\$25.00	per attendant

**Waiting time:** Waiting time begins upon arrival at the scheduled appointment and ends upon departure from that appointment. Waiting time will be charged \$8.00 each 15 minutes, or fraction thereof, if persons are not ready for departure at the scheduled pick up time.
